Re: Amendment for Revised Pricing in accordance to design changes and equipment pricing updates

Description of Quote: Scientel has prepared this quote to provide the City of Aurora, IL (Aurora) with the additional cost incurred since the inception of this project due to the following:

1. Equipment and material pricing increases for cameras and radios from 2021 (when original budgetary Quotes were secured during the Grant Application), to the actual date of orders and procurement in 2023 (following grant award).
2. Increase in Genetec Camera Server Pricing due to:
 - a. 3-year lag which caused supplier pricing increase in 2023
 - b. Adjusted sizing needs for 45 days of retention per APD requirements.
3. Increase in Pole procurement pricing due to sizing and supply chain availability.
4. Additional hardware, equipment or materials identified during design finalization and:
 - a. (12) additional cameras: LPR's and quad Q6100 to optimize views.
5. Additional infrastructure such as:
 - a. New power runs where no existing infrastructure present
 - b. Additional conduit and cabling where existing conduits have no room and/or are damaged.

All changes above have been discussed in detail and approved by both Aurora's project management team and APD, as well as the state representatives assigned to this project.
