He stated that the City of Aurora receives approximately \$1.5 million dollars of Community Development Block Grant funds annually and around \$700,000 dollars in HOME funds. He gave a summary of the City of Aurora Citizen Participation Process.

Mr. Ragona provided the Block Grant Working Committee with a summary of the proposed Annual Action Plan Substantial Amendment (2022-#1) and the 2022 Annual Action Plan. Mr. Ragona also provided an overview of the 2022 Annual Action Plan's HOME allocations which are based upon level funding as per the City's 2021 allocation of \$752,348. The proposed 2022 HOME allocations are based upon the following breakdown: 10% Program Administration, 15% Community Housing Development Organization Set-aside, 75% Direct Project Activities. The program administration and CHDO percentages are based upon HUD's regulatory thresholds. Mr. Ragona advised that any specific HOME activities will be presented for Substantial Amendment review/approval at a future BGWC meeting .Discussion took place.
