Mr Kopacz,

Thank you for the opportunity to submit the following proposal for the project referenced above.

Scope

CUT OVER

- 1. Julie route and establish location of all utilities.
- 2. Furnish and install approx. 680' of (3)1.25" poly duct with tracer and pull rope via directional bore.
- 3. Furnish and install (1) 30" x 48" HH.
- 4. Furnish and install (1) locate ped at new HH.
- 5. Furnish and install approx 700' of 144ct OSP SM FOC from existing HH 19-1 to new HH with slack coils in each HH.
- 6. At HH 19-1, pull existing back bone 144ct cable into trailer, prep in new 144ct cable.
- 7. Furnish and install new 450D case at new HH pull new 144ct into trailer and prep into new 450D case.
- 8. After normal business hours, cut existing 144ct at each HH and demo. Splice new 144ct to existing 144ct at HH 19-1 and at new HH.
- 9. Make sure circuits are back up and resplice any needed fibers.
- 10. Update SEP for 19-1 and create new SEP for newly added HH.

NEW BUILD

- 1. Furnish and install (2) 1.25" from HH 19-1 and HH 20-10 to new building.
- 2. Furnish and install building penetrations for new routes.
- 3. Furnish and install new 144ct SM FOC's from each HH to the building.
- 4. Furnish and install (2) new loaded panels for the newly installed fiber in racks by others.
- 5. Perform fusion splicing of fibers TBD.
- 6. Review, compile and submit test results package.
- 7. Repair turf with seed and blanket.
