RESOLUTION NO. R15-348  
DATE OF PASSAGE December 22, 2015

A Resolution Authorizing the Purchase of Excess Liability and Cyber Liability Insurance for the Period of December 31, 2015 through December 31, 2016.

WHEREAS, the City of Aurora has a population of more than 25,000 persons and is, therefore, a home rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970; and

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the City Council has determined it is in the best interests of the citizens of Aurora that the City purchase \$35,000,000 of excess general liability insurance and purchase cyber liability insurance for the period of December 31, 2015 through December 31, 2016; and

WHEREAS, the proposal from Arthur J. Gallagher for coverage through National Casualty Insurance Company, Torus National Insurance Company, Endurance American Insurance Company and Illinois National Insurance Company best meets the City's excess liability and cyber liability coverage requirements at the lowest cost. A Premium summary is attached hereto for reference

WHEREAS, the 2016 City Budget provides \$234,169.00 for this item in account no. 601-0000-410-40-40.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Aurora, Illinois, as follows: that one (1) year of excess general liability insurance be purchased from National Casualty Insurance Company, Torus National Insurance Company and Endurance American Insurance Company and cyber liability insurance through Illinois National Insurance Company through insurance broker Arthur J. Gallagher with a December 31, 2015 effective date of coverage inclusive of premiums and brokerage fees for the total cost of \$234,169.00.


