RESOLUTION NO. R 20-043 DATE OF PASSAGE Permany 25,2020

A Resolution authorizing the purchase of bulk loads of unleaded and diesel fuels from Petroleum Traders Corporation of Fort Wayne, IN not to exceed \$883,000.00.

WHEREAS, the City of Aurora has a population of more than 25,000 persons and is, therefore, a home rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970; and

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the City of Aurora participates in the Kane County, IL solicitation for the purchase of unleaded and diesel fuel products, and

WHEREAS, Kane County, IL awarded the contract for the purchase of bulk unleaded and diesel fuels to Mansfield Oil Company of Gainesville, GA per Resolution 19-393, and

WHERAS, due to a clerical error, the Kane County, IL board rescinded the contract award to Mansfield Oil Company and awarded the contract for the purchase of bulk unleaded and diesel fuels to Petroleum Traders of Fort Wayne, IN, per Kane County Resolution 19-418, and

WHEREAS, \$883,000.00 is budgeted in account 120-4431-418.62-40 for the purchase of bulk unleaded and diesel fuels in 2020, and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Aurora, Illinois, as follows: The approval of Petroleum Traders Corporation for the purchase of bulk loads of unleaded and diesel fuels for the City of Aurora in an amount not to exceed \$883,000.00.
