The bid opening will also be live streamed, access details to be provided to all plan holders.

Name: State Street Water Main Replacement

Location: State Street between Sixth Avenue and Schomer Avenue.

Proposed Improvement: Installation of 620 of directionally drilled 8" water main, replacement of 8 lead water services and other miscellaneous appurtenances all in accordance with the Plans and specifications.
