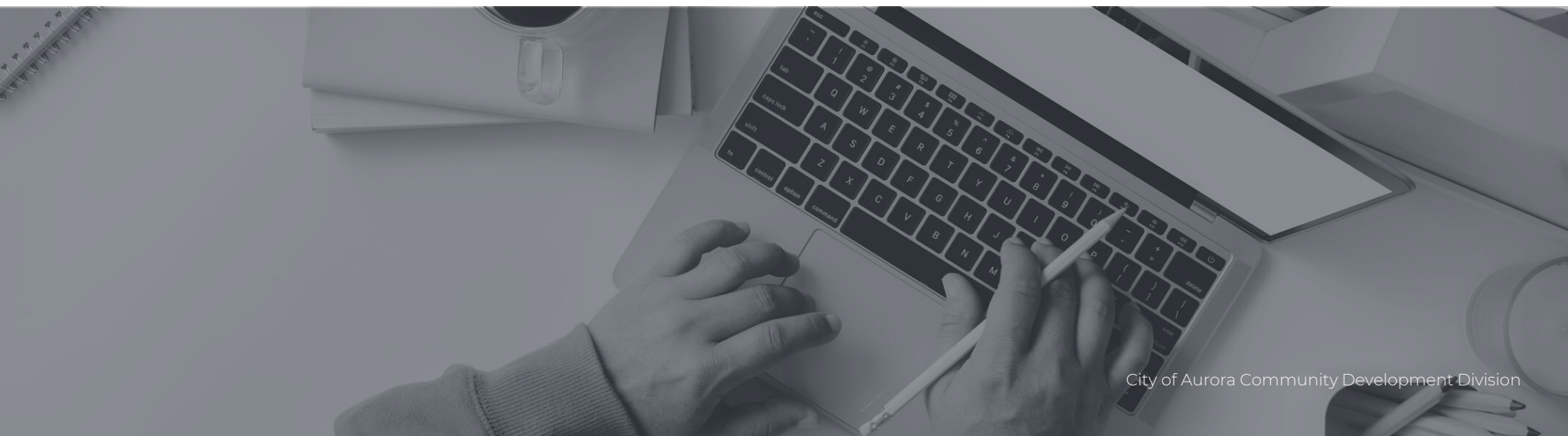

# THE RESIDENTS WE SERVE

## COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

City of Aurora residents, households and local neighborhoods that qualify as low-moderate income (4-person household with income below \$83,350) qualifies as low-income for CDBG)

Neighborhood projects must serve a low-moderate income population percentage of at least 51%

HUD-defined Presumed Benefit groups:

- Abused children
- Elderly persons (62 years old)
- Battered spouses
- Homeless persons
- Severely disabled adults
- Illiterate adults
- Persons living with AIDS

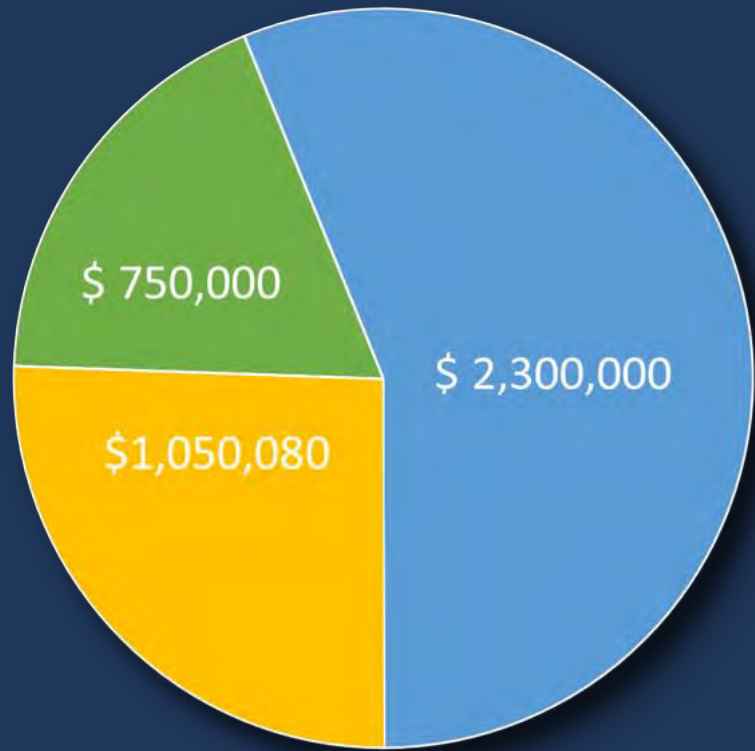


# THE RESIDENTS WE SERVE

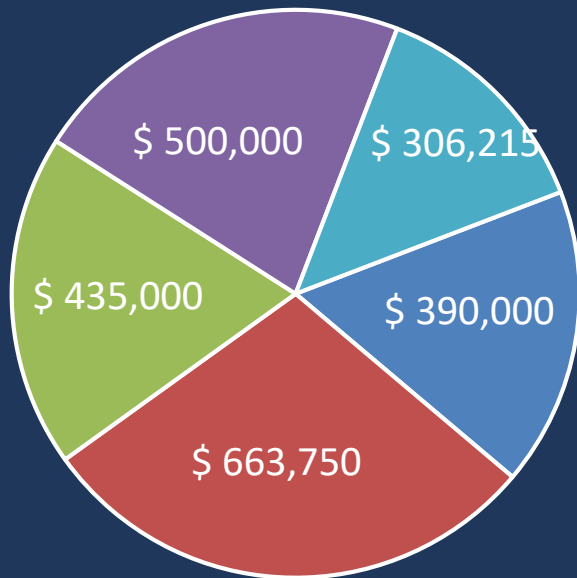

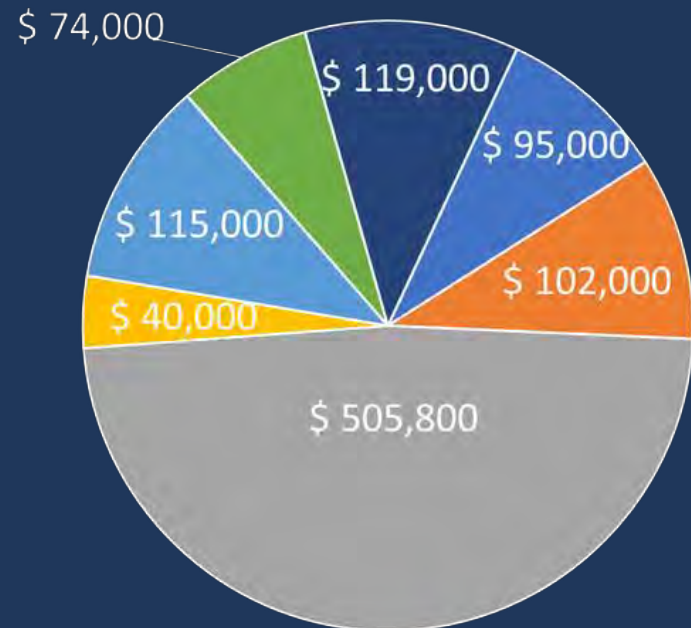

# The Neighbor Project *Safety First Program*

*Community Development Block Grant - \$665,000 since 2020*

Funds can be used for code violations, health and safety, lead, and emergency situations



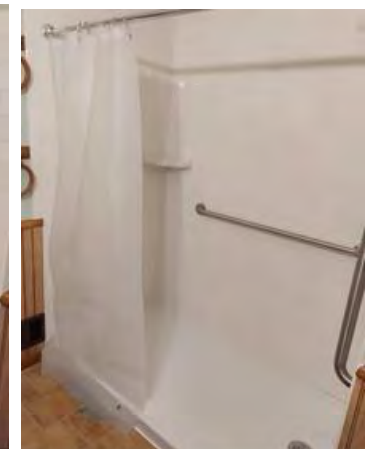
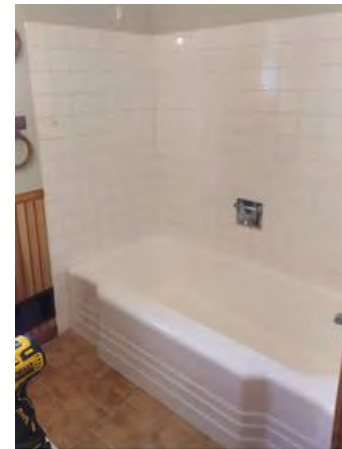
CDBG Funding – Up to \$10,000 (\$5,000 forgivable loan, \$5,000 deferred loan)

# Rebuilding Together Aurora *Safe at Home Program*

*Community Development Block Grant - \$175,000 since 2020*



Funds can be used for ADA improvements such as grab bars, ramps, and accessible bathrooms.





CDBG Funding – Up to a \$5,000 grant






## CHOOSE AURORA Homebuyer Assistance Forgivable Loan Program


Apply to Choose Aurora after you pre-qualify for a mortgage loan and your offer to purchase a home within the City limits of Aurora is accepted. Make your application a minimum of 4-6 weeks before your anticipated closing date.


- 


**ELIGIBLE HOMES**  
Existing homes, single units (condo, townhome, single family, etc.), within the City limits
- 


**MAXIMUM ASSISTANCE**  
Up to \$3,000 for eligible homes within the City limits; up to \$5,000 for eligible homes within the City's Neighborhood Revitalization Strategy Area ([NRSA](#))
- 


**MAXIMUM PURCHASE PRICE**  
Must be 95% or less than the area median purchase price by county (Kane & Will \$240,000; DuPage \$291,000; Kendall \$218,000 for 2021)
- 


**OWNER OCCUPANCY**  
Must be primary residence for three year term; may not rent or subdivide
- 

**FORGIVABLE LOAN**  
Zero interest, no payment; lien is released after homebuyer abides by terms of agreement (3 years)
- 

**FIRST TIME HOME BUYER**  
Must not have owned a home for at least 3 years or lost home due to divorce or disaster
- 

**INCOME ELIGIBILITY**  
Household income must be 80% or less than HUD's area median income (AMI) (80% of the 2022 AMI for a household of 4 is \$83,350)
- 

**MORTGAGE LENDER**  
Homebuyer must secure a 30 year, fixed rate mortgage from a lender of their choice
- 

**MINIMUM CONTRIBUTION**  
Homebuyers must pay a minimum of \$1,000 toward the purchase of the home
- 

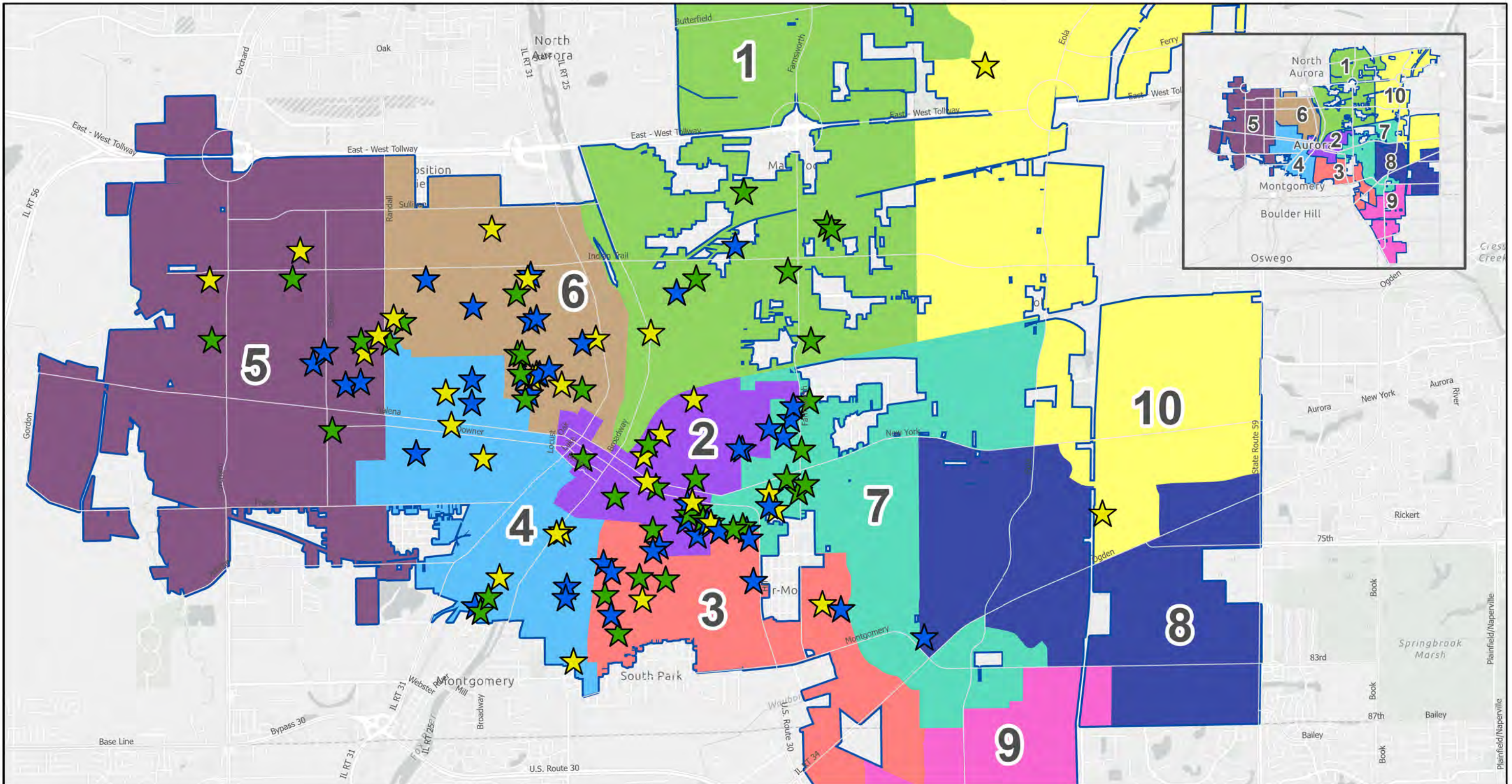
**HOME BUYER EDUCATION**  
Not required for this program, but strongly recommended
