



- Start At fire hydrant on Stonebridge Blvd 67' 3" N of Water /Sewer Manhole on NW corner of exit lane from Gwendolyn Brooks Elementary School
- Mile 1 On N side of Stonebridge Blvd at center of T intersection at Stonebridge Blvd and Greenlake Dr.
- Mile 2 On W side of Stonebridge Blvd 48' 6" S of fire hydrant on SW corner of Stonebridge Blvd abd Brookside Ln/Arborside Ln
- Mile 3 On E side of Stonebridge Blvd 42' 6 S of corner where bike path transitions into the sidewalk
- Finish 32' 8" S of crosswalk on parking lot drive opposite entrance #3 to Granger School
