If Purchaser notifies supplier of any Product Warranty issues during the duration of the Product Warranty (as specified above), Manufacturer will as promptly as reasonably practicable repair the affected Product in accordance with the terms of the Product Warranty. Supplier will reasonably cooperate with Purchaser in order to minimize the impact of the repair on Purchaser’s operations.

Out of Warranty Information:

Supplier maintains spare parts in inventory for currently available products, out of warranty products may be maintained/rejuvenated and/or rebuilt during non-peak season months at a quoted and contracted cost. In season repairs are deemed as Emergency repairs and will be billed on a T&M basis with a minimum 2 hour labor service charge for on-site visits.
