WHEREAS, the City of Aurora has a population of more than 25,000 persons and is, therefore, a home rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970; and

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals and welfare; and

WHEREAS, the Intergovernmental Cooperation Act, 5 ILCS 220/1 et seq., and Article VII, Section 10 of the Illinois State Constitution (1970) provide for the sharing and joint exercise of powers, privileges and authority that may be exercised by participating public agencies; and

WHEREAS, the Village of Sugar Grove has requested the City of Aurora activate their outdoor emergency warning sirens for monthly testing and tornado warnings; and

WHEREAS, the Village and the City have reached agreement as to the terms within which the City of Aurora would activate the Village of Sugar Grove's emergency warning sirens, a copy of which Agreement is attached hereto and made a part hereof.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Aurora, Illinois, that the Mayor and City Clerk are hereby authorized to execute and effect the attached Agreement for Activation of Emergency Warning Sirens by and between the Village of Sugar Grove and the City of Aurora.

AGREEMENT FOR ACTIVATION OF EMERGENCY WARNING SIRENS

WHEREAS, The Village of Sugar Grove has determined that it does not have the capability to activate its' outdoor emergency warning sirens twenty four (24) hours per day, each day of the year; and

WHEREAS, The Village of Sugar Grove has determined that it is in the best interest of their constituents to have said sirens activated monthly for testing and further, activated for tornado warnings or other emergencies; and

WHEREAS, The City of Aurora has the capability to so activate said sirens, and further, the City Council of the City of Aurora has determined that it is in the best interests of its constituents to activate Sugar Grove's outdoor emergency warning sirens monthly for testing and for tomado warnings or other emergencies.

NOW THEREFORE, in consideration of the above stated recitals, it is hereby agreed by and between the Village of Sugar Grove and the City of Aurora, as follows:

- 1. The above stated recitals are incorporated by reference into and as a part of this Agreement.
- The Village of Sugar Grove assumes full responsibility for providing its constituents with the following information:
 - A. The day(s) and time(s) when the sirens will be tested, and any other information pertaining to the testing of the sirens;
 - B. The weather conditions and/or other criteria that must be met before the sirens can be activated.
- 3. The City of Aurora agrees to test the sirens at least once per month.
- 4. The City of Aurora agrees to activate the sirens in the event the City of Aurora is notified of an occurrence that meets the City of Aurora's activation criteria.

- 5. The Village of Sugar Grove agrees to hold harmless, defend and indemnify the City of Aurora for any liability, including but not limited to personal injury, economic or property damage, arising out of the testing, operation or activation of the sirens, or otherwise arises as a result of the City of Aurora activities pursuant to this Agreement, or which is asserted against the City of Aurora solely due to entering into this Agreement.
- 6. This Agreement shall continue from time to time until either of the parties hereto gives the other notice of its intent to terminate sixty (60) days prior to the intended termination date.

WHEREAS, the Village of Sugar Grove, Illinois ("Village") and the City of Aurora, Illinois ("City") have determined that it is in the best interests of their residents to coordinate the location of two (2) outdoor emergency warning sirens in the Village; and

WHEREAS, the Village and the City have previously entered into an agreement whereby the City tests and activates the Village's outdoor emergency warning sirens.

NOW, THEREFORE, in consideration of the above stated recitals, it is hereby agreed by and between the Village and the City as follows:

- 1. The above stated recitals are incorporated by reference into and as a part of this Agreement
- 2. The City agrees to purchase, install and maintain an outdoor emergency warning siren that will be located at the site of the Village's outdoor emergency warning siren near the interchange of Galena Boulevard and Route 56 in the Village.
- 3. The Village agrees to relocate its existing outdoor emergency warning siren near the interchange of Galena Boulevard and Route 56 to a location to be mutually agreed upon by the Village and City and located within the boundaries of the Village. The parties further agree the ownership and control of said siren shall remain with the Village.
- 4. The parties hereto shall make their best efforts to install and relocate said sirens before December 31, 2001.
