**RESCIND THE AWARD OF RESOLUTION 19-393 TO AN INCORRECT VENDOR AND
CORRECT THE AWARD TO AUTHORIZE THE PURCHASE OF GASOLINE AND DIESEL
FUEL FOR DIVISION OF TRANSPORTATION, SHERIFF'S OFFICE, BUILDING
MANAGEMENT, AND OTHER INTERGOVERNMENTAL AGENCIES - (BID 45-019)**

WHEREAS, bids have been solicited and received by the Kane County Purchasing Department for the purchase and bulk delivery of gasoline and diesel fuel to the Kane County Division of Transportation, Sheriff's Office, Building Management for power generator, and Intergovernmental Agencies ; and

WHEREAS, through Resolution 19-393 Mansfield Oil Company of 1025 Airport Parkway SW., Gainesville, GA 30501 was incorrectly awarded a contract as the lowest, responsive, responsible bidder for all fuel products due to a transcription error on the extended bid tab; and

WHEREAS, the Notice of Award was sent to all six (6) participating Vendors of Bid 45-019, with Purchasing Staff being notified that an error occurred in the mark-up cost for Petroleum Traders Corporation as reported in the final bid tabulation for Resolution 19-393; and

WHEREAS, it was determined after the award of Resolution 19-393 that Petroleum Traders Corporation of 7120 Pointe Inverness Way, P.O. Box 2357, Fort Wayne, IN is the correct lowest, responsive, responsible bidder for all fuel products per bid specifications based on the "low side" as published in the "OPIS Price Index" to commence from December 1, 2019 to November 30, 2020; plus the following additional charges; and

WHEREAS, Blu Petroleum, 21402 W. Hwy 60 Mundelein, IL 60060 was determined to be the lowest responsive, responsible bidder for the tank wagon delivery of fuel products per bid specifications based on the "low side" as published in the "OPIS Price Index" to commence from December 1, 2019 to November 30, 2020, plus the following additional charges:

WHEREAS, the gasoline and diesel fuel shall be delivered by said low bidder to the Kane County Division of Transportation (KDOT) and deposited in the underground storage tanks located at the KDOT facility; and

WHEREAS, the gasoline fuel shall be delivered by said low bidder to the Kane County Sheriff's Office and deposited in the underground storage tanks located at the Sheriff's Office facility; and

WHEREAS, the gasoline and diesel fuel shall be delivered by said low bidder to the various Kane County Power Generators at multiple locations and other Intergovernmental Agencies and deposited in both the underground and aboveground tanks as specified within bid document; and

WHEREAS, the funding for Gasoline and Diesel Fuel has already been appropriated as part of the 2020 budget; and

WHEREAS, it is in the best interest of the County to rescind Resolution 19-393 for the contract award to Mansfield Oil of Gainesville, GA and Blu Petroleum of Mundelein, IL and award the contract to Petroleum Traders of Fort Wayne, IN and Blu Petroleum of Mundelein, IL, the two most responsive, responsible low bidders for the purchase and delivery of no-lead gasoline and diesel fuel; and

WHEREAS, by the Kane County Board that rescinding Resolution 19-393 for the award of Bid 45-019 to Mansfield Oil of Gainesville, GA and Blu Petroleum of Mundelein, IL for the correct award of contract to Petroleum Traders Corporation of Fort Wayne, IN and Blu Petroleum, LLC of Mundelein, IL for the sale and bulk delivery of fuel products (No-Lead Gasoline, Bio Diesel #2 (B5), Bio Diesel #2 - Pre Blend Winter Mix 80/20, and Winterized Diesel 50/50) as specified per Kane County Bid 45-019 Gasoline and Diesel Fuel delivered to both the underground and aboveground tanks located at the Kane County Division of Transportation, Sheriff's Office, various County's electric power generators, and other Intergovernmental Agencies be accepted. The contract price for No-Lead Gasoline and all Bio Diesel Fuels shall be based on the low side of "OPIS Price Index" plus above listed "markup" per gallon.

NOW, THEREFORE, BE IT RESOLVED by the Kane County Board that Resolution 19-393 is hereby rescinded and that the Chairman is authorized to enter into a one (1) year contract with two (2) renewal options for bulk delivery of No-Lead Gasoline and Bio Diesel Fuel with Petroleum Traders of Fort Wayne, IN and Blu Petroleum, LLC of Mundelein, IL for (small quantity wagon delivery) commencing December 1, 2019 to November 30, 2020.
