**CITY OF AURORA, ILLINOIS
SERVICES AGREEMENT**

THIS AGREEMENT, is entered on the Effective Date between the City of Aurora, Illinois (“City”) an Illinois home rule municipal corporation, with its office of City Clerk located at 44 E Downer Place, Aurora, Illinois and Family Services Association of Greater Elgin Area (“FSA”), for the Services herein described. The terms “Effective Date,” “Contractor,” and “Services” shall be defined as set forth in Exhibit A.

1. **Scope of Services.** FSA shall perform the Services set forth in Exhibit A and any attachments thereto. The purpose of this Agreement is to identify the roles and responsibilities of the Parties in their collaboration and implementation of the Program, specifically, the selection and provision of four (4) Full Time Qualified Mental Health Professionals for the term of the Agreement.. If agreed upon by FSA and the City, FSA may substitute one Full Time position with two (2) Part Time Qualified Mental Health Professionals, to function as Police Social Workers (“PSWs”), and a maximum of three Student Interns, currently enrolled in the Masters of Social Work program, Counseling, Psychology or other related field, with a preference for Masters in Social Work. All to provide services at the Aurora Police Department (“APD”) under the parameters and guidelines set forth herein. Full-time PSWs will work 40 hours a week.

2. **Term.** The term of this Agreement shall be as set forth in Exhibit A. If provided in Exhibit A, the Agreement shall renew without further action by the Parties as set forth in therein, provided that the City Council of the City has budgeted funds for the services contemplated by this Agreement. Request for a review period will occur 3 months prior to the renewal date.

3. **Standard of Performance.** Contractor shall perform all Services set forth in this Agreement, and any other agreed documents incorporated herein, with the degree, skill, care and diligence customarily required of a professional performing services of comparable scope, purpose and magnitude and in conformance with the applicable professional standards. Contractor shall, at all times, use its best efforts to assure timely and satisfactory rendering and completion of the Services. Contractor shall ensure that Contractor and all of its employees or subcontractors performing Services under this Agreement shall be: (i) qualified and competent in the applicable discipline or industry; (ii) appropriate licensed as required by law (LSW or LSW eligible within 6 months and under supervision of a LCSW, LMFT, or LCPC.); (iii) strictly comply with applicable federal, state, and local laws, regulations or ordinances; and (iv) strictly conform to the terms of this Agreement. Contractor shall, at all times until the completion of the Services, remain solely responsible for the professional and technical accuracy of all Services and deliverables furnished, whether such services are rendered by the Contractor or others on its behalf, including, without limitation, its subcontractors. PSWs will receive 6-month performance reviews to be completed by Contractor with supporting information from APD. Annual job description reviews will occur to ensure there are performance metrics and requirements that are clearly outlined. No review, approval, acceptance, nor payment for any and all of the Services by the City shall relieve the Contractor from the responsibilities set forth herein.

4. **Payment.** Contractor shall invoice the City for its Services rendered in the amount and with the frequency set forth in Exhibit A. In the event, that FSA does not provide staff as agreed upon in Schedule A, invoices shall be prorated to reflect the staff and time of services actually rendered. Upon receipt, the City shall review and process such invoices for payment in accordance with the procedures and the time limitations provided by the Local Government Prompt Payment

Act. Approved but unpaid amounts shall accrue interest and penalties in the amount and to the extent authorized by the Act.

5. **Termination for Convenience.** Either Party has the right to terminate this Agreement, in whole or in part, for any reason or in case of the City, if sufficient funds have not been appropriated to cover the estimated requirement of the Services not yet performed, by providing the other Party with thirty (30) days' notice specifying the termination date. On the date specified, this Agreement will end. If this Agreement is terminated by the City, as provided herein, the City shall pay the Contractor only for services performed up to the date of termination. After the termination date, Contractor has no further contractual claim against the City based upon this Agreement and any payment so made to the Contractor upon termination shall be in full satisfaction for Services rendered. Contractor shall deliver to the City all finished and unfinished documents, studies and reports and shall become the property of the City except for any clinical records or mental health professional records of FSA not required for compliance with the Department of Justice, Community Orientated Policing Services Grant.

6. **Indemnification and Insurance.**

- a. **Insurance.** The Contractor shall provide to the City evidence that it has obtained and maintains the insurance coverages set forth in Exhibit B. In all cases, the Contractor shall provide the City with a certificate naming the City and APD as an additional insured party and shall not cancel such insurance without prior notice to the City.
- b. **Indemnification.** Contractor shall indemnify, defend, and hold harmless the City, its elected officials, officers, and employees from and against all claims, losses, damages, costs and expenses, including without limitation, reasonable attorney's fees arising from or out of Contractor's performance of its obligations under this Agreement, including specifically those brought by third parties, except that neither FSA, nor any of its agents or employees shall be liable to any extent for any injury or damage arising out of or caused by or resulting from the negligent acts or omissions of the City, or APD, their employees, officers or other agents.
- c. **Non-Wavier.** Neither by the insurance or indemnifications requirements of this Agreement does the City waive any privilege, defense, or immunity, which may be available to it, its elected officials, officers, or employees by law, including, but not limited to those set forth in the Local Governmental and Governmental Employees Tort Immunity Act.

7. **Miscellaneous Provisions.**

- a. **Illinois Freedom of Information Act.** The Contractor acknowledges the requirements of the Illinois Freedom of Information Act (FOIA) and agrees to comply with all requests made by the City of Aurora for public records (as that term is defined by Section 2(c) of FOIA in the undersigned's possession and to provide the requested public records to the City of Aurora within two (2) business days of the request being made by the City of Aurora. The undersigned agrees to indemnify and hold harmless the City of Aurora from all claims, costs, penalty, losses and injuries (including but not limited

to, attorney's fees, other professional fees, court costs and/or arbitration or other dispute resolution costs) arising out of or relating to its failure to provide the public records to the City of Aurora under this agreement. FSA shall not be required to produce records protected by the Illinois Mental Health and Developmental Disabilities Confidentiality Act (MHDDA) pursuant to 740 ILCS 110/et seq and The Health Insurance Portability and Accountability Act of 1996 (HIPAA), Public Law 104-191 unless otherwise required by law.

- b. **Mutual Respect and Positive Work Environment.** Both FSA and APD agree to foster mutual respect and create a positive, collaborative work environment. This includes:
Promoting open communication and transparent decision-making.
Upholding professionalism in all interactions.
Ensuring that all individuals involved in the program are treated with dignity and fairness.
Encouraging teamwork, mutual support, and continuous program improvement to enhance productivity and engagement.
Both entities commit to cultivating an atmosphere of respect and cooperation, recognizing that a positive working relationship is essential for the success of the Police Social Work program and its impact on the community
- c. **Entire Agreement.** This Agreement, along with the documents set forth in Section 1 and incorporated by reference elsewhere in this Agreement, with consent of the parties, represents the entire agreement between the parties with respect to the performance of the Services. No other contracts, representations, warranties or statements, written or verbal, are binding on the parties. This Agreement may only be amended as provided herein.
- d. **Consents and Approvals.** The Parties represent and warrant to each other that each has obtained all the requisite consents and approvals, whether required by internal operating procedures or otherwise, for entering into this Agreement and the undertakings contemplated herein.
- e. **Counterparts.** This Agreement may be executed in one or more counterparts, each of which shall be an original, but all of which shall constitute one and the same instrument.
- f. **Jurisdiction and Venue.** The Parties agree that in the event of litigation arising from this Agreement, the exclusive venue for the adjudication of such disputes shall be the Circuit Court of the Sixteenth Judicial Circuit, Kane County and that the Illinois law shall apply to such disputes without regard to its choice of law principles.
- g. **Construction of Contract Provisions.** The Parties acknowledge that this Agreement and all the terms and conditions contained herein have been fully reviewed and negotiated by the Parties. Having acknowledged the foregoing, the Parties agree that any principle of construction or rule of law that provides that, in the event of any inconsistency or ambiguity, an agreement shall be construed against the drafter of the agreement shall have no application to the terms and conditions of this Agreement.
- h. **No Third Party Beneficiaries.** This agreement is entered into solely for the benefit of

the contracting parties, and nothing in this agreement is intended, either expressly or impliedly, to provide any right or benefit of any kind whatsoever to any person or entity who is not a party to this agreement, or to acknowledge, establish or impose any legal duty to any third party.

- i. **Independent Contractor.** Contractor is an independent contractor for all purposes. Contractor shall manage its own work. Contractor shall not be considered the agent or employee of the City for any purpose and shall not hold itself out as such.
- j. **Notices.** All notices required hereunder shall be made in writing and shall be served personally, by registered mail, certified mail, traceable private courier services, electronic mail or facsimile transmission unless otherwise provided in this Agreement.

Payment Terms

- a. Subject to the limitations of the annual City budget the total compensation paid to FSA by the City under this Agreement, inclusive of all costs and expenses shall not exceed a total of \$455,617.92 during the twelve (12) month period commencing on the date of execution of the agreement.
- b. FSA will provide four (4) Full Time Qualified Mental Health Professionals for the term of the Agreement. If agreed upon by FSA and the City, FSA may substitute one Full Time position with two (2) Part Time Qualified Mental Health Professionals, and up to three (3) student interns as outlined in paragraph of Exhibit A.
- c. The City will pay the Contractor's invoices on the following schedule:

d. The City shall pay the Contractor for its documented actual time and expenses and shall reimburse the Contractor for the documented services of its employees and subcontractors. The total aggregate payment to the Contractor by the City for all of the Contractor’s time, expenses, and reimbursements, shall not exceed the total Contract Amount. All invoices and supporting documentation shall be submitted. If part-time employees are utilized, expenses per part-time employee for 2025 shall not exceed \$4,083.50 per month and for 2026 shall not exceed \$4,328.51 per month. If FSA does not provide staff as agreed, invoices shall be prorated to reflect the staff and dates of services rendered. City shall receive a credit for the up-front payment. Invoices shall be submitted with all receipts and supporting documentation and shall be paid by the City according to the terms of the Illinois Local Government Prompt Payment Act (50 ILCS 505/1, *et. seq.*). If the City fails to pay amounts owed when due, the Contractor may declare the City in breach of this Agreement. All invoices and any supporting documentation shall be sent via email as requested by the City to PurchasingDL@aurora.il.us or by mail to City of Aurora, Attn: Purchasing Division, 44 E. Downer Place, Aurora, Illinois 60505.

- c. Subcontracted services and expenses shall include:
 - o FSA program(s) costs limited to Police Social Worker salaries/compensation and other related expenses, as indicated in the Scope of Work.

Scope of Work

The Contractor agrees to perform the Services set forth herein pursuant to this Agreement.

- a. Hire and employ Qualified Mental Health Professionals, as defined in the Illinois Administrative Code, with a Master of Social Work, Master of Psychology or other related degree, to serve as the Police Social Workers (“PSWs”) as part of the Aurora Police Department’s Crisis Intervention Unit, formally known as the CITE program.
- b. FSA shall follow its standard hiring practices for the recruitment and selection of PSWs, which include resume screening, phone screening, a vignette case response, and an in-person interview process. FSA retains the right to make final hiring decisions under EEOC compliance. This hiring authority is part of FSA’s broader responsibility for clinical oversight, professional standards, risk management, and legal compliance required to operate a licensed mental health program within a law enforcement setting.
 - a. FSA shall coordinate with APD to conduct joint in-person interviews for qualified candidates.
 - b. Both FSA and APD will collaboratively review and discuss the candidates interviewed and provide recommendations.

- c. All hiring decisions shall remain with FSA, ensuring compliance with employment laws, clinical supervision standards, and agency policies.
- c. Obtain the interview feedback or concerns of the Lieutenant who oversees CIU or a higher authority prior to the hiring of any Police Social Worker candidate. This response should be provided to Contractor within five (5) business days and shall not be unreasonably withheld.
- d. FSA agrees that the City is providing additional consideration to FSA to compensate its social workers that will be designated as Police Social Workers and work with the City. FSA retains discretion for determining competitive compensation, benefits, and coverage as appropriate based on the nature and role of the employee's position. FSA shall exercise their best efforts to provide competitive compensation and benefits to limit turnover of program staff. Provide all necessary compensation, benefits, and coverage to the Police Social Worker(s), who at all times shall remain an employee of FSA. FSA and its Police Social Worker (s) and/student interns shall not be considered the agent or employee of the City for any purpose and shall not hold itself out as such. FSA will perform all payroll functions for the Police Social Worker(s).
- e. Any communication regarding performance, progressive discipline, termination, compensation, benefits, shift coverage, and overall position management of the Police Social Workers will be handled by their FSA supervisor(s). Nothing shall prevent APD personnel from providing on the spot feedback to the employee, when the supervisor is not immediately available, with subsequent notification to the supervisor.
- f. Select, in cooperation with APD, and employ Student Interns currently enrolled in a Master of Social Work or similar program to serve as interns and participate in the APD Crisis Intervention Unit. It is understood that these programs are not a full year in duration.

FSA provides **clinical supervision**, while APD provides **non-clinical supervision of Police Social Workers**. FSA shall provide all clinical supervision and oversight for the Police Social Workers (PSWs) to ensure adherence to mental health best practices, ethical standards, and professional licensing requirements. APD shall provide non-clinical supervision through designated leadership, including an APD Sergeant or higher-ranking official and the APD City Social Worker, who will oversee daily workflow, case assignments, and task management. The APD City Social Worker shall serve as a task manager, ensuring seamless coordination with APD operations.

- g. Follow and ensure the Police Social Worker(s) and Student Intern(s)' compliance with Program guidelines and APD procedures and policies.
- h. Communicate on a regular basis with APD regarding the status of the Program, including performance of the Police Social Worker(s) and intern(s) selected under this Agreement.
- i. Ensure that the Police Social Worker(s) and Student Intern(s) timely submit to a comprehensive criminal background check, to be performed by APD or its designee.
- j. Manage metrics to coincide with the objectives of the program. Said metrics will be designed to identify needs and efficacy of the program and be made available to APD.

- k. Provide appropriate bulletproof vest for FSA employees.
- l. Both Parties shall collaborate on identifying and applying for supplemental funding, with priority given to grants that align with the Program's objectives and ensure sustainability of services. FSA agrees that grant and/or supplemental funding shall be used first and prior to requesting any APD funding.

FSA Police Social Worker(s) Responsibilities

- a. General: The Police Social Worker(s) shall at all times remain an employee of FSA. At no time shall the Police Social Worker(s) be considered an employee, agent, or volunteer of APD or the City. FSA agrees that the Police Social Worker(s) shall be assigned solely to the APD, and shall be stationed at APD Headquarters, located at 1200 E. Indian Trail Rd., Aurora, Illinois 60505. He or she shall work either twenty (20) hours if part-time or forty (40) hours per week if full-time, pursuant to a schedule agreed upon by FSA and in coordination with APD. (See Exhibit A) He or she shall work under the supervision of FSA and shall at all times adhere to APD policies and procedures while at APD. APD will provide nonclinical supervision. The Police Social Worker(s) must pass a criminal background check performed by APD or its designee prior to commencement of his or her services. PSWs may be required to adjust schedules based on crisis response needs, with advanced coordination between FSA and APD.
- b. Job Duties & Scope of Response: The Police Social Worker shall respond, as requested by APD or at times the Aurora Fire Department, to persons with, or believed to be impacted by mental illness, developmental delay, intellectual disability, brain injury, cognitive impairment, or addiction. He or she will also, as needed, assist the Investigations Division with victim services and outreach efforts. The Police Social Worker (PSW) shall work pre-approved shifts, assigned in coordination with FSA and the APD Crisis Intervention Unit (CIU). The FSA Chief Clinical Officer (CCO) shall ensure that services align with best practices in mental health, crisis response, and trauma-informed care.

The daily workload and case assignments for the PSWs shall be determined by an APD Sergeant or higher-ranking APD official or their designee, in collaboration with the APD City Social Worker and FSA leadership as needed. In addition, the Police Social Worker shall be responsible for the following non-exclusive job duties:

- i. Co-respond with APD to a crisis situation when the scene is safe for them to enter. They will then coordinate transportation regardless of insurance providers;
 - The PSW may respond to crisis situations when the scene has been deemed safe by APD personnel, providing:
 - Immediate de-escalation and stabilization techniques.
 - Brief therapeutic interventions, such as motivational interviewing, crisis intervention, psychoeducation, and safety planning.
 - Rapid linkage to appropriate resources (e.g., community-based mental health providers, housing assistance, substance use treatment).

- Coordination of transportation for individuals in crisis, including hospital transfers if needed.
- ii. Respond to subjects whom, in the opinion or judgment of APD, are in need of clinical services;
- iii. Attend internal trainings or education forums as deemed necessary by APD and FSA. The PSW may provide internal training or educational support to APD personnel related to mental health awareness, trauma-informed care, and crisis intervention strategies
- iv. Case management: Assignment of Workload & Coordination
 - The PSW shall receive daily and ongoing case assignments from an APD Sergeant or higher-ranking APD official or their designee, with input from the APD City Social Worker regarding case coordination and prioritization.
 - The FSA Chief Clinical Officer (CCO) shall provide oversight on clinical best practices and ensure alignment with FSA policies and professional standards.
- v. Collaboration Across APD Divisions
 - The PSW shall work with various APD divisions and departments, including but not limited to CIU, Investigations, Patrol, and other specialized units seeking social work expertise.
- vi. Program Leadership & Development
 - FSA shall collaborate on the broader program development to ensure quality service delivery, staff training, and adherence to mental health best practices.
 - The APD City Social Worker shall serve as a task manager facilitating day-to-day operations.
- vii. Case Consultation & Resource Connection. The PSW shall provide:
 - Guidance on cases involving individuals experiencing mental health crises, substance use concerns, or other social service needs.
 - Direct referrals and linkage to community services, treatment programs, and victim advocacy resources.
- viii. Ongoing Case Support & Follow-Up (Non-Therapeutic)
 - The PSW shall assist in monitoring and following up on cases to:
 - Ensure individuals successfully connect to long-term services.
 - Reduce repeat law enforcement involvement by addressing social determinants of crisis.
 - Provide brief follow-up interventions as needed (e.g., check-ins, service navigation support) but shall not engage in long-term therapy or case management.
- ix. The APD Sergeant or designated leadership may assign additional duties or

special projects within the scope of the PSW's role. FSA retains the right to review and approve assignments to ensure alignment with clinical best practices, professional ethics, and contractual obligations. The FSA CCO and APD City Social Worker shall be involved in discussions regarding any modifications to program scope, staff responsibilities, or evolving service needs.

x. Management of the APD Special Needs Aurora Police Program.

c. Access to Records and Facilities: The Police Social Worker will have access to:

i. APD internal computer system and resources for the limited purpose of researching the location and contact information of those in need of services, i.e. Records Management Systems (RMS, WebRMS), computer aided dispatch systems (CAD) via Cad Watch, and case management. FSA and its employees shall maintain strict confidentiality regarding any police records accessed and shall comply with all APD policies on data security. Unauthorized use or disclosure of sensitive information may result in revocation of system access.

ii. I Suite/I Access to review reports or run searches for reports designated CIU or mental health;

iii. WebRMS to complete, when necessary, supplemental reports to non-criminal offenses. Any such reports must be submitted to APD for approval;

iv. APD Outlook e-mail account for Police Social Worker(s)

v. Special Needs Aurora Police Program (SNAPP) Excel Spreadsheet for data entry and information residing solely in SNAPP

vi. An APD radio while on duty with assignment of an administrative call sign;

The radio is to be kept onsite and in the social work office when not in use. It may be used by interns during field visits but must always be returned upon their return to APD.

vii. The general or open areas of APD unless otherwise approved by APD; and

viii. Other APD resources as deemed necessary for performance of job duties.

FSA Student Interns' Responsibilities:

a. General: The Student Interns shall be current students in the Master of Social Work program at an accredited university. At no time shall the Student Interns be considered employees, agents, or volunteers of APD or the City. The Student Interns shall be assigned solely to the APD, and shall be stationed at APD Headquarters, located at 1200 E. Indian Trail Rd., Aurora, Illinois 60505 They shall work a designated number of hours per week, pursuant to a schedule agreed upon by FSA. The Student Interns shall work

under the shared supervision of FSA and shall at all times adhere to APD policies and procedures. FSA will directly manage the clinical and daily supervision of said interns. The Student Interns must pass criminal background checks performed by APD or its designee prior to commencement of their services.

- b. Job Duties: The Student Interns may be responsible for providing services at the APD, including at the front desk, interview rooms, and potentially in the field as determined by FSA. APD may request student intern assignments from FSA. Student Interns may also receive assignments or direction from APD or the Police Social Worker(s).
- c. Access to Records and Facilities: Access to APD systems will be limited to APD outlook e-mail. Access to APD facilities will be limited to the general, open areas of APD unless otherwise approved by APD.

APD will, subject to the availability of funding provided in Exhibit A:

- a. Cooperate with FSA in the hiring of the Police Social Worker(s) and Student Interns.
- b. Provide the Police Social Worker(s) and Student Intern(s) with physical access to select APD property during their assigned working hours as set forth herein.
- c. Provide the Police Social Worker(s) and Student Intern(s) with select access to APD records, body camera footage and data pursuant to the guidelines set forth herein.
- d. Provide supervision and training to the Police Social Worker(s) and Student Intern(s) in accordance with APD policies and procedures, and report back to FSA about their performance and any issues of concern. Training will include ride along, co-response, police radio, basic medical and safety protocols in line with APD policies and procedures.
- e. Conduct or cause to be conducted a comprehensive criminal background check of the Police Social Worker(s) and Student Intern(s) prior to commencement of their services.
- f. Issue an official APD civilian / contractor identification and building access card to assigned social work partners.
- g. APD shall provide workspace for all FSA social workers and interns assigned to APD. FSA employees including Human Resource employees or management responsible for APD assigned social workers and interns will also be granted access to APD, after clearing an APD background check and after they become CJIS compliant. APD will allow other FSA employees to use our Front Lobby Interview Rooms to make phone calls or meet with clients based on availability of those rooms. FSA employees may also enter the secure areas of APD when working on issues directly related to APD, when escorted by an APD assigned FSA Social Worker or APD personnel.

EXHIBIT B

INSURANCE REQUIREMENTS

FSA shall maintain minimum insurance and indemnity limits of not less than \$1M per person, \$1M aggregate, and shall name the City and APD as additional insureds on a primary and noncontributory basis. FSA shall provide to the APD proof of liability insurance within thirty (30) days of acceptance of this Agreement and prior to commencement of any FSA employee and /or intern assignment at APD. FSA shall notify the APD in the event of any changes to or cancellation of said liability insurance.

At the FSA 's expense, the FSA shall secure and maintain in effect throughout the duration of the entire agreement, insurance of the following kinds and limits to protect the City from and against all damages, claims, lawsuits and losses which may occur or arise with regard to the FSA's business operations on behalf of the City of Aurora. The TPA shall furnish Certificates of Insurance to the City upon request. All insurance policies shall be licensed to do business in the State of Illinois and having a rating of not less than A IX, according to the latest edition of the A.M. Best Company; and shall include a provision preventing cancellation of the insurance policy unless thirty (30) days prior written notice (ten (10) days in case of nonpayment of premium) is given to the City. This provision shall also be stated on each Certificate of Insurance as: "Should any of the above described policies be canceled before the expiration date thereof, the issuing company will endeavor to mail 10 days written notice to the certificate holder named herein".

The City may inspect any and all policies of insurance at any time. If requested, the FSA will give the City a copy of the insurance policies. The policies must be delivered to the City within ten business days of the request.

The limits of liability for the insurance required shall provide coverage for not less than the following amount, or greater where required by law:

- (1) Worker's Compensation Insurance - Statutory amount.
- (2) General Liability Insurance:
 - (a) \$1,000,000 per occurrence and \$1,000,000 general aggregate
 - (b) \$500,000 per occurrence for Property Damage
 - (c) \$1,000,000 per occurrence for Personal Injury
- (3) Auto Liability Insurance:
 - (a) Bodily injury with limits not less than \$1,000,000
 - (b) Property damage with limits not less than \$500,000
- (4) Umbrella excess liability of \$1,000,000 each occurrence, \$1,000,000 aggregate

The FSA shall include the City of Aurora as a primary, non-contributory additional named insured on both General and Auto Liability Insurance policies and reflect said language on its Certificate of Insurance provided to the City.

The FSA shall keep and hold the City harmless from and against any and all costs, damages, causes of action, claims of any nature whatsoever, whether known or unknown at law or in equity, or before any court, agency or commission, or any other such public body of the local, state or federal governments, or expenses it may suffer, incur or sustain or become liable for, or on account of any injury to, or death of its employees, or to any other person, or damage to, or injury to real estate, or personal property caused by, or arising out of, or resulting from, the negligence or willful misconduct of the FSA, its agents, employees or subcontractors, in performance of its day-to-day operations, performance of its duties and obligations under this Agreement, and use or occupancy of any City property as described herein.

If FSA fails to comply with the insurance requirements contained herein, the City's obligations under the agreement shall terminate. The Contractor, at its own expense, shall secure and maintain in effect throughout the duration of this contract, insurance of the following kinds and limits to cover all locations of the Contractor's operations.
