Description of Work

Name: Borealis Terrace Drive-way, Sidewalk, and Drainage Improvements
Location: Along Austin Avenue, between Constellation Drive and Comet Drive, and along Constellation Drive, between Star Avenue and Austin Avenue.
Proposed Improvement: Removal and replacement of PCC driveway approaches, PCC sidewalks and catch basin frames and grates, as well as installation of approximately 50 feet of 12 Inch RCP and other miscellaneous appurtenances all in accordance with the plans and specifications.
