5. If pumping, dewatering, sheeting, shoring, undercutting, rock excavating, discing, drying, increasing trench size, adding safety equipment, or frost ripping are required, additional costs may be incurred unless specifically indicated in bid.
6. Spoils generated from others not included in pricing except where indicated.
7. Placement of aggregate materials machine grade to +/- one tenth foot of grade. No hand labor is included unless indicated.
8. Building wall shoring for backfill is not included.
9. Pricing good for 30 days. However, significant material price, fuel or labor increases will be passed on to customer.
10. We are not responsible for tree or shrub loss due to excavation.
11. Terms are net 30. Interest based on 1.5 percent per month (18 percent annually) will be charged on past due accounts.
12. Please remember that JULIE must be notified on all digs which may delay start times 4-5 days.
13. Any facility that is not located by the standard JULIE call, that will require a private locate shall be the responsibility of others to locate. Any damage or costs resulting from the damage of an unmarked or miss marked facility will NOT be Campton Constructions responsibility.
14. No "as-built" drawings will be supplied. Campton will only supply RED LINE drawings.
