Ward 3 Facade and Site Improvement Grant Program

PURPOSE: The City of Aurora's Ward 3 Façade and Site Improvement Grant Program is intended to encourage business property owners and tenants in Ward 3 to re-invest in and renovate their buildings and properties. The Invest Aurora Grant Committee will consider each case on its individual merits.

GUIDELINES

GEOGRAPHICSCOPE:

Eligible rehabilitation projects must be commercial or mixed-use properties within the Ward 3 municipal boundaries. Please see the attached boundary map on Page 2 if you are unsure if your property is located in this boundary.

AMOUNT OF GRANT:

The minimum project that will be funded is \$10,000. The grant reimburses 50 percent of the total rehabilitation costs, but not to exceed \$25,000.00 in grant funds. The amount of the grant will be determined based on total project costs.

GRANTS ARE DISBURSED AS REIMBURSEMENTS AFTER THE PROJECT IS COMPLETE, ALL CONTRACTORS HAVE BEEN PAID AND SIGNED LIEN WAIVERS, AND A CERTIFICATE OF OCCUPANCY IS OBTAINED FROM THE CITY OF AURORA.

APPLICATION TIMELINE:

Invest Aurora's Grant Committee will review each proposal upon receipt of a completed application. The committee meets as necessary. All application materials must be submitted the Friday before the committee meeting in order to be reviewed. An applicant will be notified in writing of a project approval/denial. An approval will be referred to as a "Commitment Letter".

PROJECT TIMELINE:

The project must be completed and secure a Certificate of Occupancy (if applicable) from the City of Aurora within 180 days from the receipt of the Commitment Letter. If the project fails to be completed or fails to secure a Certificate of Occupancy (or equivalent) within 180 days, the Commitment Letter will be considered invalid and no prior approved funds will be disbursed. Approved applicants may request a 90 day extension of the grant commitment. Extension requests should be submitted at least 21 days before the grant commitment is set to expire and should outline reasons for delay, updated construction timeline, and progress to date.

REIMBURSEMENT:

The grant will be in the form of reimbursement upon completion of the project ². Before the grant can be disbursed, the applicant must provide:

- Proof of payment for completed work
- Lien waivers from all contractors and subcontractors
- A copy of the Certificate of Occupancy (or equivalent) from the City of Aurora
- A Completed Form W-9 is on file with Invest Aurora


CONDITIONS:

In addition to all other conditions cited in these Guidelines and Application, Invest Aurora may place certain other conditions, restrictions, or stipulations upon each project if the Invest Aurora Grant Committee or the Alderman determines such conditions to be necessary in order to further the orderly development of Ward 3.

REVIEWCRITERIA:

The Invest Aurora Grant Committee reviews each application on a case-by-case basis. Applicants are encouraged to provide as much information as possible about the project in order for the committee to make an informed decision. The grant approval process can be competitive.

- Proof of business registration with City of Aurora.
- Proof of property ownership e.g., property warranty deed, current property tax bill, or land contract registered with the appropriate county. If the applicant is not the building owner, a letter of consent from the owner and a copy of the executed lease.
- Proof of financial funds in the form of a bank statement or letter of approved financing from a lender.
- Photographs of the building with current conditions.
- A plan drawn to scale, elevations, if any, altered façade drawn to scale.
- Construction Timeline.
