PURPOSE:

To award the McCoy Drive and Cheshire Drive Traffic Signal Installation project to H & H Electric Company and the appropriation of \$520,195.62 of Motor Fuel Tax (MFT) funds for the project.

BACKGROUND:

The project consists of installing a new traffic signal at the intersection of McCoy Drive and Cheshire Drive, sidewalk improvements, refresh striping & pavement markings, combination curb and gutter removal and replacement, adding appropriate signage, restoration and other miscellaneous work in accordance with the plans and specifications.

DISCUSSION:

The project bid was advertised on April 7, 2024. The City opened bid on May 1, 2024, the bidder was H&H Electric Company at \$520,195.62.

WHEREAS, a qualified bid was received through the open bid process and the qualified bid was from H & H Electric Company of Franklin Park, IL, in the amount of \$520,195.62.

WHEREAS, there is a need to appropriate Motor Fuel Tax (MFT # 23-00361-00-TL) funds for this project in the amount of \$520,195.62, a copy of which resolution is attached for approval.
