DATE OF PASSAGE	

A Resolution appointing four inaugural members Didi Foley, Michael Summers, Alex Benitez and Braden Smith for a two-year term to the Music, Events and Entertainment Commission (MEE). WHEREAS, the City of Aurora has a population of more than 25,000 persons and is, therefore, a home rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970; and

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the Music, Events and Entertainment Commission (MEE) shall consist of a total of eleven (11) board members; and

WHEREAS, it is the Mayor's desire that said candidates be appointed.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Aurora, Illinois, hereby approve the appointment of four inaugural members Didi Foley, Michael Summers, Alex Benitez and Braden Smith for a two-year term to the Music, Events and Entertainment Commission (MEE).

NOW BE IT FURTHER RESOLVED that the term of the four members shall expire on January 1, 2026, however, in any event, they shall continue to serve until reappointed or their respective replacement has been approved by the Council.
