DISCUSSION:

In June of 2021, the City Council approved changes to Chapter 2, which included a sunset provision for all board/commission members. The sunset was included to bring the board/commission terms into compliance with the new dates provided in the ordinance, as well as survey members if they wished to continue to serve or step down.

The nomination brought forth today represents three veteran candidates.

Seth Hoffman is a resident of the sixth ward of Aurora.

Amber Foster is a resident of the sixth ward of Aurora.

Simon Munoz is a resident of the second ward of Aurora.

A Resolution authorizing the reappointments of Seth Hoffman, Amber Foster, and Simon Munoz to the Aurora Preservation Commission.

WHEREAS, the City of Aurora has a population of more than 25,000 persons and is, therefore, a home rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970; and

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals, and welfare; and

WHEREAS, Chapter 2 of the Code of Ordinances provides that the Mayor, shall, with the approval of the City Council, appoint the members of the advisory boards and commissions of the City; and

WHEREAS, in accordance with Chapter 2 of the Code of Ordinances, the Mayor has notified the City Council of the appointments of the individuals listed in Exhibit A thru C of this resolution to the Aurora Preservation Commission and to the term therein enumerated, and has requested the City Council's approval of said appointment; and

WHEREAS, the City Council finds that the appointees set forth in Exhibit A thru C of this resolution possess the necessary qualifications to serve on the Aurora Preservation Commission in the position to which they have been nominated:

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Aurora, Illinois, as follows that the appointments of the individuals listed in Exhibit A thru C of this resolution shall be and hereby are approved.
