SUBJECT:

BACKGROUND:

This document accompanies Legistar File 23-0872, the proposed updates to Chapter 47. In the process of updating Chapter 47 entitled "Trees, Shrubs and Weeds", there were a number of references to the "Arboricultural Specifications Manual". A document from 2008 that does not appear to have been approved by the City Council was located and updated in concert with the proposed changes to Chapter 47.

A Resolution approving the Arboricultural Specification Manual for the City of Aurora. WHEREAS, the City of Aurora has a population of more than 25,000 persons and is, therefore, a home rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970; and

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals, and welfare; and

WHEREAS, Chapter 47 of the Code of Ordinances calls for City Council approval of an Arboricultural Specifications Manual; and

WHEREAS, city staff and volunteers, including certified arborists, participated in the drafting of this document; and

WHEREAS, it is in the best interest of the city to have this document updated and available to the public.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Aurora, Illinois, as follows: That Exhibit A of this Resolution shall be and hereby is adopted and replaces the prior Arboricultural Specification Manual for the City of Aurora.
