Our Lady of Mercy Church / Alpine Amusement Company, Inc. have applied for a Carnival license to be held at Our Lady of Mercy Church on Thursday, September 29, from 12:00 p.m. to 10:00 p.m.; Friday, September 30, 2016 from 12:00 p.m. to 10:00 p.m., Saturday, October 1, from 12:00 p.m. to 10:00 p.m.; Sunday, October 2, from 12:00 p.m. to 10:00 p.m. and a Music Festival on Friday, September 30, 2016 from 12:00 p.m. to 10:00 p.m., Saturday, October 1, from 12:00 p.m. to 10:00 p.m.; Sunday, October 2, from 12:00 p.m. to 10:00 p.m. .

### BACKGROUND:

This yearly event will include Music groups, food and games. Our Lady of Mercy Church has been holding this event for at least a decade.

**DISCUSSION:**

The Applicant has provided the required documentation for the Music Festival and are currently still working on obtaining the additional requirements for the Carnival Application. The applicant will be submitting the required Health Department permit, Food and Beverage registration, List of Carnival Workers, and the Security Form prior to the approval by the City Council.

City Staff (Fire Prevention, Police Department, Law Department and the City Clerk's Office) will work closely with them to ensure all requirements are met prior to the issuance of a license.
