DATE OF PASSAGE

A Resolution Reappointing Marge Linnane, Leticia Morales-Perez, William Powell and Ramona Wood to the Aurora Civil Service Commission.

WHEREAS, the City of Aurora has a population of more than 25,000 persons and is, therefore, a home rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970; and

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the Aurora Civil Service Commission has member's with expired terms and;

WHEREAS, it is the Mayor's desire that said candidates be reappointed to said commission.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Aurora, Illinois, hereby approve the reappointments of Marge Linnane, Aurora, IL Leticia Morales-Perez, Aurora, IL William Powell, Aurora, IL and Ramona Wood, Aurora, IL to Aurora's Civil Service Commission.

BE IT FURTHER RESOLVED that the terms of Marge Linnane, Leticia Morales-Perez, William Powell and Ramona Wood shall expire June 30, 2018, however, in any event, they shall continue to serve until their respective replacements have been approved by the Council.
