In addition to supporting community-wide events in Aurora, the AAHAB also hosts a yearly scholarship dinner.

There are currently vacancies and expirations on the board.

WHEREAS, the City of Aurora has a population of more than 25,000 persons and is, therefore, a home rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970; and

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals, and welfare; and

WHEREAS, there are currently vacancies on the Aurora African American Heritage Advisory Board; and

WHEREAS, it is the Mayor's desire that the recommended candidates be appointed and reappointed to said board.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Aurora, Illinois, hereby approve the appointments of Glenda Blakemore, Aurora, IL Stephanie Mack, Aurora, IL and reappointments of Toshia Moss, Aurora, IL, Aurora, IL, Kimberly Harris, Aurora, IL, Cynthia Miller, Aurora, IL, Deb Goss-Johnson, Aurora, IL, Marc Dale, Naperville, IL, and Adrienne Coleman, Aurora, IL to the Aurora African American Heritage Advisory Board.

BE IT FURTHER RESOLVED that the term of Adrienne Coleman shall expire on April 30, 2020, the terms of Glenda Blakemore, Toshia Moss, Kimberly Harris, Cynthia Miller, Deb Goss-Johnson, and Marc Dale Jr. shall expire on April 30, 2021, and the term of Stephanie Mack shall expire on April 30, 2022, however, in any event, they shall continue to serve until their respective replacements have been approved by the Council.
