Unit 36-283 is a 2015 Ford Utility Police Interceptor that was involved in an accident. This vehicle was inspected by local auto body repair companies and the accident damage was determined to be a total loss.

The "at fault driver" is insured with American Access Casualty Company however their policy has a \$20,000.00 maximum payout.

The City's Property Claims Account 601-0000-410-4076 has available funds to cover the purchase of this vehicle.

Currie Motors is the approved dealer on the Suburban Purchasing Cooperative for the 2017 Ford Utility Police Interceptor.
